WHAT WE ARE/WHAT WE DO:

The Northeast Washington Education Council (NEWEC) is a tax-exempt 501 (c)(3) organization affiliated with and assisting the educational mission of Spokane-based NEWESD 101.

NEWEC was formed to diversify and stabilize NEWESD 101 funding during a time of declining revenue and growing need. NEWEC receives, manages and distributes income and gifts supporting NEWESD 101 and, ultimately, students in northeastern Washington.

NEWEC and NEWESD 101 serve 59 public school districts, 45 state-approved private schools and three state-approved charter schools enrolling 104,232 students (grades PK-12, 2019-20).

NEWEC SERVICES: Specific areas of focus include: math and science; at-risk youth; staff development for local educators; scholarships; and partnerships between business and education.

NEWEC SERVICE AREA: Adams, Ferry, Lincoln, Pend Oreille, Spokane, Stevens and Whitman counties.

NEWEC MISSION: The foundation serves the region on many levels: as an applicant for grants serving the region's schools; as an "umbrella" foundation for school districts that do not operate their own foundations; and as a recipient of cash and gifts earmarked for educational services.

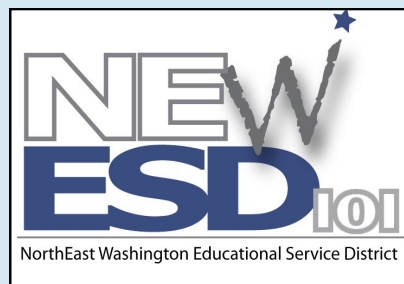
