### HISTORY OF THE REC

The Rural Education Center (REC) was established in 1987. The idea of the REC came out of a Washington Association of School Administrators (WASA) Small Schools Committee. The need for a research-based service organization had been discussed for many years.

As a public research university committed to its land-grant heritage and tradition of service to society, the College of Education at Washington State University decided to partner with a group of small school districts to help advance the needs of small and rural districts in our state. The original concept was then further developed by Dr. Brian Talbott, who at the time was Superintendent of ESD 101, and Dr. Ray Smith, the inagural director, with advice and encouragement from WASA's Small Schools Committee.

Originally the major task for the REC was the development of a database addressing a variety of subjects. It consisted of financial reports, staffing and program information. The first years were spent compiling and sharing studies on subjects of interest to small schools including, Cooperation vs. Consolidation, In-Service needs, Small School funding formula, Student Course selection, Drop-out rates of Small Schools, and others.

As the Directorship has changed so has the focus of the Center. To date REC has become an increasingly important voice at the State level for small and rural schools. State associations and legislative bodies hold REC in high regard when asked for information on issues affecting small and rural schools across Washington.

HB 1139 – Named the Rural Ed. Center at WSU to be one of the key partners with The WSAC (Student Achievement Council) to submit a report on the field placement of student teachers with strategies on increasing the recruitment and retention of candidates in rural and remote school districts

**Invited** by legislative committees to present information on small and rural schools in our state

**Provided** testimony on numerous educational bills at the request of legislators

**Partnered** with ESD 113 to publish a "Research Brief" on Rural School Graduation Rates in WA State

**Partnered** with several organizations to successfully keep the small high enhanced funding in place

REC Director served on the recent WASA "Hold Harmless" workgroup which helped result in additional funding from the 2019 Legislature


